

**Minutes of the Meeting of Cantley Parish Council held on  
Thursday 16<sup>th</sup> March 2017 at 7pm in Limpenhoe Village Hall.**

**1. Public Forum**

A member of the public reported to the Council that there had been varying issues with the roadworks from Cantley to Acle, going through Beighton. He circulated a folder of photos and issues, noting that the health and safety risks were not acceptable, that the workers had no welfare facilities, and that litter was being left on the side of the road. He had had little positive response from Norfolk County Council on this matter. The Clerk was asked to send the complaint to her contact in Streetworks at Norfolk County Council, copying in County Councillor Andrew Proctor.

i. Ropes Barn Caravan Site

iii. Limpenhoe Grit Bin

The Clerk reported that the bin had been agreed for relocation onto the straight section between the two bends. Norfolk County Council would install it once the Clerk had taken it to the Caister depot.
