- 1. Apologies for absence were received from Kevin Francis and Peter Key. All agreed.
- 2. No declarations of interest or applications for dispensations for items on the agenda were given
- 3. Public Forum and County and District Councillor Reports

Issues raised by the Public:

- The Council website is out of date. The Clerk is working on this.
- The Blofield and District Conservation Group (BADCOG) have been together for 40 years carrying out various conservation projects in the area. It was asked if the Council would like to write a letter of congratulations to them. **All agreed.**
- When is the factory opening. It is believed it will be October but no formal notification has been received.

The village hall committee has indicated that it will soon be ready to carry out the rebuild of the facility. Alternative venues for hirers to be considered during the works. Preference to be the British Sugar Training Centre and St Margarets Church. The village hall will update at the next Council meeting.

- a. Issues relating to highways
 - road signs being turned around and a damaged 40mph sign on Station Road have been reported to NCC Highways.
 - The hedge along Well Road, Limpenhoe is in need of trimming as the road is becoming more narrow and affecting visibility. The Clerk to report to Highways.
- b. An update on the Parish Partnership application was heard. The application is still current and Westcotec have met with Steve to agree the 3 positions for the SAM2: Station Road dual position, and two on Burnt House Road. These will be shared with NCC Highways for approval and then the paperwork can be completed and the SAM2 purchased.
 - A grant application for an improved trod path across the churchyard from the top of Church Road is in progress.
